**Application Procedure is same to become Regional Area Coordinator (RAC).  
SPC Education Center not collects any extra charges for RAC.**

- **Guidelines of Regional Area Coordinator**

1. SPC not collecting any charges for RAC (Regional Area Coordinator) and going to appoint any person/Institute/society/Trust/Company etc as RAC as per requirement of applicant and according to his/her sound profile of organization.
2. RAC can Develop new study centers between **10 to 15** Kilometer distance in his area, supply correct information and guide new study center if there are any query beside it before collect any document from new center first inform & confirm with SPC then collect all required documents as per our terms & condition.
3. It is responsibility of RAC that he/she develop minimum 10 new study center every month and he/she will provide us complete detail of New Center when he collected all documents. RAC will neither collect cash amount regarding Inspection & approval charges SPC accept only in form of DD, nor collect any extra charges for any other purpose.
4. After completion of approval process SPC will send approval to center after join SPC education center by new center, for this responsibility SPC will give Rs. **500/- to 1000/-** per New center one time at time of approval and **3% to 5%** of monthly grant/income which is receive by new study center from SPC.

**Detail of motivation of RAC**

Number Of Center	Period	Motivation
1 to 10	1 Month	1000*Number of center + 3% of Grant
10 to 15	1 Month	1000*Number of center + 3% of Grant
10 to 20	1 Month	1000*Number of Center +3% of Grant
20 to 30	1 Month	1200 *Number of Center + 4% of Grant
30 to 40	1 Month	1200 *Number of Center + 4% of Grant
40 to 50	1 Month	1400 *Number of Center + 5% of Grant

**Explanation of First Month Income:**

During first month study center open 10 new study centers then study center is eligible Rs. 1000 per new center ( $10*1000=10,000$ ) and 3 % of total grant receive by all new centers.

Suppose average grant amount of per center is 50,000 then ( $50,000*10=5,0000$ ) now 3 % of grant is  $5,0000*3/100=15,000$ .

Total Amount =  $10,000+15,000=25,000$ .

**From Third month RAC/Study center receive Rs. 1, 15,000/- per month Income.**

5. If SPC refer any address and contact detail for new franchisee to RAC then motivation of RAC will 50% less according to standard.
6. All responsibility carries by RAC like Advertisement, necessary infrastructure, executive for Document collection, Control/monitoring etc.
7. It is responsibility of RAC that he /she watch that each center working or not in proper manner as per our terms and condition.
8. RAC not collect any type of amount from Study center regarding admission, books etc. Study center directly send all amount to SPC.
9. Handle and check the status of new center and send us proper reports.
10. Continuously monitor all activity of study center.
